Restrictive covenants and other matters concerning Shadow Creek Ranch are set forth in Declaration of Covenants, Conditions and Restrictions for the Village of Emerald Bay, recorded in the Office of the County Clerk of Brazoria County, Texas, under Clerk's File No. 01 043210 (the "Emerald Declaration"); Restrictive covenants and other matters concerning Shadow Creek Ranch are set forth in Declaration of Covenants, Conditions and Restrictions for the Village of Reflection Bay, recorded in the Office of the County Clerk of Brazoria County, Texas, under Clerk's File No. 03 080263 (the "Reflection Declaration"); Restrictive covenants and other matters concerning Shadow Creek Ranch are set forth in Declaration of Covenants, Conditions and Restrictions for the Village of Biscayne Bay, recorded in the Office of the County Clerk of Brazoria County, Texas, under Clerk's File No. 2004034202 (the "Biscayne Declaration"); and Restrictive covenants and other matters concerning Shadow Creek Ranch are set forth in Declaration of Covenants, Conditions and Restrictions for the Village of Diamond Bay, recorded in the Office of the County Clerk of Fort Bend County, Texas, under Clerk's File No. 2005017655 (the "Diamond Declaration"), as each may have been and/or may be supplemented and amended from time to time;


