What are the responsibilities of the Board of Directors?

Responsibilities of the Board of Directors, as defined by your Village's Bylaws, can be reviewed by using the QR code. Please reference Articles V through VIII.



The Board is responsible for providing directions for repair and maintenance, administration, financial well-being, deed restriction compliance, and general betterment of the Association. Serving as a member of the Board of Directors is a valuable and rewarding experience, and the best opportunity to serve your Village of Reflection Bay HOA community.

Who is the Village of Reflection Bay's Management Company?

FirstService Residential is the management company for Shadow Creek Ranch Maintenance Association and the Village Associations. The role of the management company is to conduct day-to-day business operations in compliance with federal, state, and local codes as well as the governing documents (Covenants, Conditions, & Restrictions). The management company also works closely with your Board of Directors by facilitating follow-through on their duties and decisions.

Where and when are the Village of Reflection Bay HOA Board of Directors meetings held?

Meetings are currently held online via Zoom early in the afternoon every other month, January through September, with an annual member meeting in October. Board Workshops may be scheduled in lieu of open Board meetings as deemed necessary. Candidates must be willing and able to participate consistently.

Who serves on the Board of Directors?

Only Members can serve on the Board of Directors. You must be listed on the deed to your property to be considered a Member of your Association.

How long are Board of Director member terms?

Board members serve a three-year term. Terms are staggered for each Director to ensure continuity year-over-year.

How do I vote?

Members will receive the invitation to vote by email from a 3rd party vendor, VoteHOA Now, (<https://villageofreflectionbay.ivotehoa.com/register>) on September 26, 2025. Be sure to check your Spam or Junk folders if you have an email address noted for your owner account and do not receive an e-ballot.

Paper ballots will be mailed to *all* homeowner *billing* addresses on Friday, September 19, with instructions on returning completed ballots to the Community Management office. *Please do not submit a paper ballot if you vote online.*

How are the winners determined?

The candidates who receive the most votes are elected.

Who tabulates the votes?

In addition to handling the voting process, VoteHOA Now, will tabulate the results.

When will the election results be announced?

The results of the election will be announced on Monday, November 3, 2025.
